COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #22-3683, which is on file with the Tulalip Tribal Court under this cause number, on or about the 14th of December, 2022, the Tulalip Tribes Police Department (TTPD) seized a 2004 Audi A4 VIN WAULC68E64A157133 from Jacob Hatch (driver) in the vicinity of 10200 Quil Ceda Blvd., Tulalip, WA 98271 in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

1	III. Claimants
2	Jacob Hatch is a person who the Tribes knows or has reason to believe has or may
3	assert a claim to the subject property. Jacob Hatch is believed to reside at 12817 47th Drive
4	NE, Marysville WA 98271.
5	IV. CONCLUSION
6	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
7	to have Jacob Hatch answer the allegations of this Petition, and, ultimately, for the Court to order
8	that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
