
I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #21-2693, which is on file with the Tulalip Tribal Court under this cause number, on or about the 3rd day of October, 2021, Tulalip Tribal Police (TPD) seized a 2002 Audi A4 & VIN # WAULT68E42A311772 from Edgardo Amaya (driver) in the vicinity of 3221 31st Avenue NE, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

A201, Auburn, Washington 98092 (Police Report).

IV. CONCLUSION

Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons to have Edgardo Amaya and Martin Hernandez answer the allegations of this Petition, and, ultimately, for the Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
