Citizen Complaint

The Tulalip Tribal Court attempts to be responsive to the community's needs and concerns while balancing the legal requirements that the Court remain fair and impartial in its decision-making.

The Court has established a process where anyone may file a citizen's complaint regarding individual court staff or the Court System. These complaint forms are for Community Members who feel that there are problems with court staff members or that specific policies are not followed.

Having a Court Complaint form helps the Court identify problems that may not be known and can help us improve our services to the community. We will track all complaints and include these complaints in our Court's Annual Report to the Board of Directors. If you wish to file a complaint, please follow these steps:

How to access the Citizen's Complaint form:

1. Contact the Court Clerk's Office to obtain a Complaint form or access online at the Tulalip Tribal Court's website www.tulaliptribalcourt-nsn.gov, to access the form under Court Forms.
2. Fill out the requested information or have someone assist you in filling out the form.
3. Return the completed form to the Court Clerk's Office to the attention of the Court Director. You may place it in a sealed envelope to the attention of the Court Director if you wish whether you wish to be contacted about this matter.
4. Email the form to Alicia Horne, Court Director, at ahorne@tulaliptribes-nsn.gov.

Once the form is received, the Court will review the complaint following this procedure:

1. The Court Director will review the complaint to determine if it falls under the guidelines as a non-legal or case-related issue.
2. The Court Director will investigate the complaint and obtain facts.
3. The Court Director will decide how to resolve the complaint.
4. A reply will be submitted to the complaining party in writing or via phone. Or, if no reply is required or requested, a notation will be entered, and the Court Director will maintain a copy of the complaint.

NOTE: These procedures do not apply to a motion for reconsideration or an appeal for the legal decision made by a judge.

You must file a motion for reconsideration within 10 days of service of the decision or order T.T.C.

2.20.110. Please confer with your attorney about any judicial decision.

You must appeal a court decision within 20 days, as provided by the Tribal Justice System T.T.C. 2.20.

Please confer with your attorney about any judicial decision.

With your help and input, the Tulalip Tribal Court will continue providing a quality judicial system for everyone. All complaints are strictly confidential.
